

The undersigned hereby submits these Articles of Incorporation for the purpose of forming a business corporation under the laws of the State of Florida:


EFFECTIVE DATE

1. The name of the corporation is Igenti, Inc.
2. The address of the initial place of business and the initial registered office of the corporation in the State of Florida is 4606 Woodlands Village Drive, Orlando, Florida, 32835; and the name of its initial registered agent at such address is James M. McArdle.
3. The number of shares the corporation is authorized to issue is ten million (10,000,000), with \$0.01 par value.
4. The name and address of the incorporator is James M. McArdle at 4606 Woodlands Village Drive, Orlando, Florida 32835.
5. To the fullest extent permitted by Florida law as it exists or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable to the corporation or any of its shareholders for monetary damages for breach of duty as a director. No amendment or repeal of this article, nor the adoption of any provision to these Articles of Incorporation inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal, or adoption.
6. These articles will become effective upon filing with the State of Florida this day, the 7th day of March, 2002.
