ARTICLES OF INCORPORATION OF
DAJO ENTERPRISES, INC.

The undersigned, acting as incorporator of a corporation to be formed under the provisions of the law of the State of Florida, hereby adopts the following articles of incorporation for such corporation, to be filed with the Secretary of the State of Florida:

ARTICLE I

The name of the corporation shall be DAJO ENTERPRISES, INC. The principle place of business of this corporation shall be 3481 SW 3rd. Avenue Miami, Florida 33145

ARTICLE II

The corporation shall have perpetual existence commencing at the filing of the Articles of Incorporation with the Department of State.

ARTICLE III

The general nature of the business to be transacted by the Corporation shall be as follows:

1. To engage in the business permitted under the laws of the United State of America and of the State of Florida, as limited by the provisions of the Florida Corporation Act.
2. To engage in real state transactions as permitted by the Florida Law, Chapter 475, Florida Status.
3. To do any and all lawful necessary business for which corporations may be incorporated under the law of Florida, as it may be suitable, necessary, useful, proper or admissible for the accomplishment of any of the purposes, or for the attainment of any of the objectives, or for the exercise of any of the powers herein set forth, whether specified or not, either alone or in connection with other firms, corporations, or individuals, either in this State or throughout the United States and elsewhere.

ARTICLE IV

The aggregate number of shares of capital stack that the Corporation shall have the authority to issue is One Hundred (100), with a par value of One Dollar (\$1.00) per share.

ARTICLE V

The initial principal office of the Corporation shall be located at 3481 S. W. 3 Avenue Miami, Fl 33145. The registered Agent shall be Jorge Palacios.

ARTICLE VI

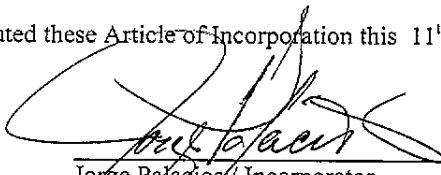

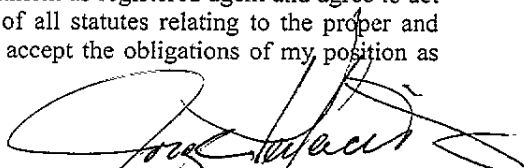
ARTICLE IX

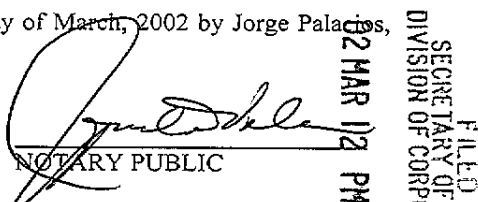
