ARTICLES OF INCORPORATION

OF

FAMOUS NAILS, INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be FAMOUS NAILS, INC. and the initial address of this corporation shall be 5072 N. Dixie Highway, Ft. Lauderdale, FL 33334.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida, including without limitation, providing carpeting, tile and wood floor services.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
