This letter is in reference to a document of notice of administrative dissolution or revocation. I have had two changes of addresses since the corporation was opened, the first one being:

950 SW Cleary Terrace, Port St. Lucie, 34952 effective April of 1992 until March of 1993. A change of address was posted with the post office. The original address of 2648 SW River Shore Dr. Port St. Lucie, 34984 was the address of my parents which have not been on speaking terms since the past year and a half, hence no mail has been forwarded nor any Department of State information mailed to my new address. An additional move has been made in April of 2003 to 442 SE Walters Terrace, Port St. Lucie 34983 which is also my current business address.
