ARTICLES OF INCORPORATION OF MARTHA CHOMIAK STUDIO INTERNATIONAL, INC.

ARTICLE 1 - NAME

The name of the corporation is: MARTHA CHOMIAK STUDIO INTERNATIONAL, INC.

ARTICLE II – PURPOSES

This corporation is organized for the following purposes:

- A. To import and export all types of cosmetics, hair care and beauty products, and other types of goods and merchandise between the United States, Venezuela, and other countries. To invest in property, both real and personal, in particular retail and wholesale establishments for the sale and provision of services related to the above, as well as other, types of products.
- B. To such extent as a corporation organized under the Business Corporation Law of this state may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other corporations, firms or individuals, all and everything necessary, suitable, convenient or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this Corporation or to enhance the value of its properties; and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the Business

Corporation Law of this state or under any act amendatory thereof, supplemental thereto, or substituted therefore.

ARTICLE III – CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock without nominal or par value.
