ARTICLE I

The name of this corporation is: BURKLOW DEVELOPMENT, INC.

ARTICLE II

The term of existence of the corporation is perpetual.

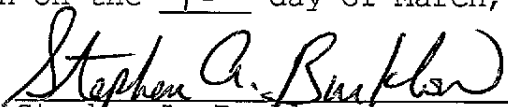
ARTICLE IX - BYLAWS

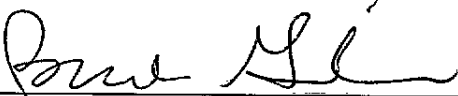
