**ARTICLES OF INCORPORATION
FOR**

OPQ, INC.

The undersigned incorporator being a person competent to contract, subscribes to these Articles of Incorporation to form a corporation under the Florida Business Corporation Act, hereby, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: OPQ, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1215 Ustler Road, Apopka, FL 32712.

ARTICLE III - CAPITAL STOCK

The number of no par value shares of stock that this corporation is authorized to have outstanding at any one time is: One Thousand (1,000) of Common Stock.

The stockholders shall be the sole judges of the value of any property, right, or thing acquired in exchange for shares of stock and their judgment of such value shall be conclusive.
