The undersigned, acting as incorporator of GANGITANO & ASSOCIATES, P.A. under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is of GANGITANO & ASSOCIATES, P.A. (the "Corporation").

**ARTICLE II. MAILING ADDRESS AND OFFICE**

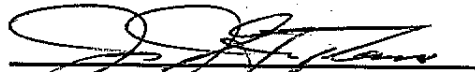
**ARTICLE VIII. BYLAWS**

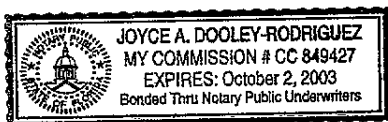

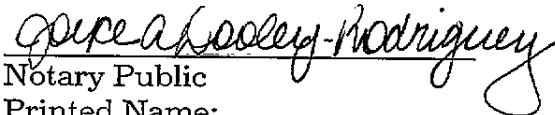
