ARTICLE I – Name and Address

The name of this corporation is ROMAC LEASING CORPORATION. The mailing address of the corporation is 4810 Culbreath Isle Road, Tampa, Florida 33629. The address of the corporation's principal office is 4810 Culbreath Isle Road, Tampa, Florida 33629.

ARTICLE II – Duration

This corporation shall have perpetual existence.

ARTICLE III – Capital Stock

This corporation is authorized to issue 100,000 shares of common stock, which shall be designated as "Common Shares." The par value of each share of stock shall be One Cent (\$0.01).

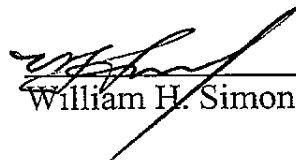
ARTICLE VII – Indemnification

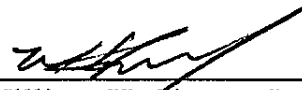
