

### ARTICLE I - NAME

The name of this Corporation is Personal Touch PT Services, Inc.

#### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on March 20, 2002.

# ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.


