TO: THE HONORABLE SECRETARY OF THE STATE OF FLORIDA

The undersigned do hereby make, subscribe, acknowledge, and file the following Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE L

The name of the corporation shall be:

"SMDS TRADING, INC."

ARTICLE IL

The general nature of the business to be transacted by the corporation shall include, but not be limited to, the following:

To conduct a business of importing and exporting of products and to perform all acts as may be necessary to accomplish the foregoing purpose of the corporation.

To buy or otherwise acquire, hold, own, manage, and control real and personal property of every description, including its own stock and stock in any other corporation or corporations, and to sell and convey, mortgage, pledge, lease, or otherwise dispose of such property or any part thereof, and to lend money, either upon or without security;

To hold, purchase, mortgage, and convey real estate and personal property in this State and in any of the several state, territories, possessions and dependencies of the United States, the District of Columbia, and foreign countries, and to apply for, obtain, register, buy lease, or otherwise dispose of patents, inventious, improvements, processes, trade marks and trade names used in connection with or secured under Letters Patent of the United States or any foreign country, and to use, develop, and grant licenses in respect of,

or otherwise turn to account, any such patents, inventions, improvements, trade marks, trade names, processes, or rights:

To conduct business at one or more offices in this State or other states and foreign countries; to enter into, make perform, and carry out contracts of every kind and for any lawful purpose with any person, firm, association or corporation;

To issue bonds, debentures, or obligations of the company from time to time for any of the objects and purposes of the company, and to secure the same by mortgage, pledge, deed of trust, or otherwise;

To purchase, hold and re-issue the shares of its capital stock, and to subscribe to, purchase, or otherwise acquire, or to guarantee, or to become surety in respect to the stock, bonds, or other securities and obligations of other companies;

To do all such things as are incidental or conducive to the premises, and to do all and every thing necessary, suitable, convenient, or proper for the accomplishment of any of the purposes or the attainment of any of the objects herein commerciated or incidental to the powers herein named, or which shall at anytime appear conducive or expedient for the protection or benefit of the corporation;

To take, acquire, buy, hold, own, maintain, work, develop, sell, convey, lease, mortgage, exchange, improve, and otherwise deal in and dispose of real estate and real property and all other kinds of property of whatsnever nature, whether real, personal or mixed, or any interest or rights therein, without limits as to amounts; to buy, sell, assign, convey, and cancel liens upon personal property and real estate of every kind and nature whatsnever; to act as broker or agent for the purchase, sale, leasing, and management of real estate and the negotiating of loans; to draw, accept, endorse, discount, and deliver bills of exchange, promissory notes, bonds, debentures, and other negotiable instruments of whatsnever nature, and to secure the same by mortgage on its property or otherwise;

In general, to carry on any other incidental business in connection with the foregoing, whether manufacturing or otherwise, and to have and exercise all the powers

conferred by the laws of the State of Florida upon corporations of this charter.

No recitation or declaration of special powers or purposes herein enumerated shall be deemed to be exclusive, but all lawful power now, or which may be conferred upon corporations for profit and/or Sub-Chapter S corporations, are hereby included and prayed for.

ARTICLE III.

The number or shares of stock under which this corporation shall have at its inception shall be One Hundred Shares (100), each share to be of no par value, all of which shares shall be issued fully paid and non-assessable. The capital stock of this corporation may be paid for in lawful money of the United Stares or in property, labor, or services at a fair and just valuation to be fixed by the stockholders or by the Board of Directors.

ARTICLE IV.

The amount of capital with which this corporation shall begin business shall be Five Hundred Dollars (\$500.00).

ARTICLE V.

The existence of the corporation shall be perpetual.

ARTICLE VI.

The principal office and place of business of the corporation shall be at: 1111 Falcon Avenue, Miami Springs, Florida, 33166, with the privilege of establishing other offices and places of business throughout the State of Florida and other states and foreign countries.

ARTICLE VIL
