The names, address and titles of the the Directors and Officers of the corporation are the same and are:

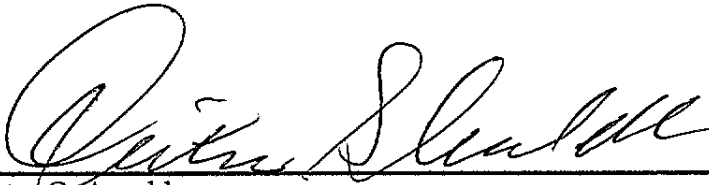

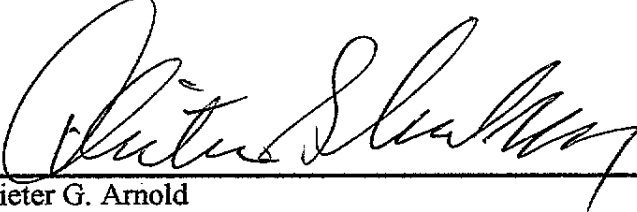
