ARTICLES OF INCORPORATION OF Yacht Marketing Group, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the FLORIDA Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be:

Yacht Marketing Group, Inc.

Article 2. Address. The location and mailing address of the principal office of the Corporation is 100 SECOND AVE. S., STE. 200, ST. PETERSBURG, FL 33701.
