**FIRST:** The date of filing of the articles of incorporation was March 18, 2002, Document Number P02000031060.

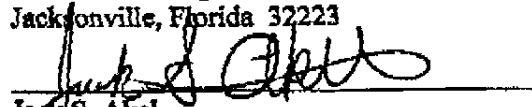
**SECOND:** The amendment to the articles of incorporation was adopted by the corporation, and shall be effective April 10, 2006.
