I. NAME

X. AMENDMENTS

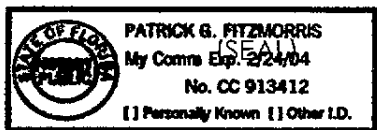




