

# ARTICLES OF INCORPORATION OF WEST COAST ALUMINUM & GLASS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE 1: NAME
