**ARTICLES OF INCORPORATION**

**FRONTENAC LAND HOLDINGS, INC.**

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of Incorporation

**ARTICLE I ~ NAME**

The name of the corporation shall be **FRONTENAC LAND HOLDINGS, INC.**

**ARTICLE II ~ PRINCIPAL OFFICE**

**ARTICLE VIII ~ REGISTERED AGENT**

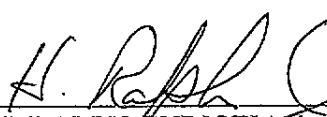
