ARTICLE I - NAME

The name of this corporation is COASTLINE INSTALLATIONS, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on the date of filing.

ARTICLE III - PRINCIPAL OFFICE


