Pursuant to the provisions of Section 607.1006, *Florida Statutes*, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

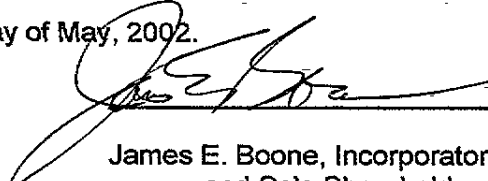
**FIRST:** Amendment adopted: The official name of the corporation is hereby changed from Race Day Water Company, Inc. to **Big Daddy's Race Day Water Company, Inc.**

**SECOND:** Any and all issued shares of stock in the name of Race Day Water Company, Inc. shall immediately be canceled and new shares of stock in the same denomination shall be issued reflecting the new corporate name; letterhead, invoices and other corporate documents are to be immediately changed to reflect the new name of the Company.
