AMENDMENT**

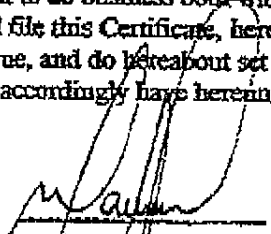
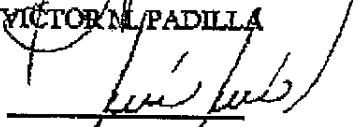
