Chapter 621, and other laws of the State of Florida.

ARTICLE I - Name:

ARTICLE II - Principal Office:

The principal office and mailing address of this corporation is 4004 West Santiago Street, Tampa, Florida 33629. The Directors from time to time may designate such other address and place for principal office of the Corporation as they deem appropriate.

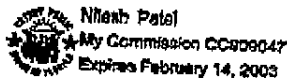

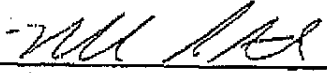
