The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation.

The name of the corporation is HGT BUSINESS SERVICES, INC.

ARTICLE II. PRINCIPAL OFFICE
