The undersigned, for the purpose of having formed a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

### ARTICLE ONE - NAME

The name of the Corporation is: J & J MUSIC BOXES

# **ARTICLE TWO - DURATION**

The duration of the Corporation is perpetual.

#### ARTICLE THREE - PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

# ARTICLE FOUR - CAPITAL STOCK

The aggregate number of shares which the Corporation authorized to issue is 1000 shares of common stock. Such shares shall be of a single class and shall have no par value. The initial shares of the Corporation shall be issued as follows:
