ARTICLES OF INCORPORATION

OF

FIRST. The name of the corporation is Performance Communication Services Inc.

SECOND. The street address of the initial principal office of the corporation is 1650 Stone Ridge Terrace, Sarasota, Florida 34232.

THIRD. The total number of shares of all classes of stock which the corporation shall have authority to issue is 110, of which 10 shares of par value \$10 per share shall be designated as Common Stock and 100 shares of par value \$10 shall be designated as Preferred Stock. 
