ARTICLES OF INCORPORATION

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name

The name of the corporation is Mathews Museum Construction, Inc.

ARTICLE II - Principal Office

The principal office and the mailing address of the Corporation is 1604 N. Marion Street, Tampa, Florida 33602, subject to change and relocation by the Board of Directors.

ARTICLE III - Duration of the Corporation
