ARTICLES OF INCORPORATION
OF
DRYROOF SYSTEMS, INC.

The undersigned incorporator, WILLIAM C. McBRIDE, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is Dryroof Systems, Inc.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 3700 North Pace Boulevard, Pensacola, Florida 32505.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of \$1.00 par value common stock.

ARTICLE V - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI - RESTRICTIONS ON TRANSFER OF STOCK

Unless waived by written agreement between this corporation and its shareholders, shares held by persons receiving shares in the initial issue of stock in this corporation may not be resold to other
