The name of the corporation is INNOVATIVE SCIENCE SOLUTIONS, INC.

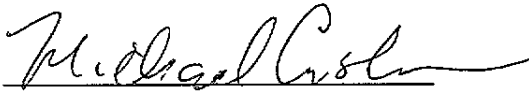
