ARTICLES OF INCORPORATION

We, the undersigned subscribers to these Articles of Incorporation, natural ATE persons and competent to contract, hereby form a corporation under the LORIDA Laws of the State of Florida.

ARTICLE I

Name of Corporation

The name of the corporation shall be: MAKAY CIGARS CORP.

ARTICLE II

Nature of Business

The general nature of business to be transacted by this corporation is retail sales of tobacco and other products as well as any other activities or business permitted under the Laws of the United States and the State of Florida.
