ARTICLES OF INCORPORATION

ARTICLE 1. CORPORATE NAME

The name of this Corporation is M.S.D. INTERNATIONAL, INC., and its business address is 1943 A Rainbow Dr., Clearwater, Florida 33765.

ARTICLE 2. NATURE OF BUSINESS

This corporation may engage in or transact: Automotive Repair and Parts, as well as any lawful activity under the laws of Florida.

ARTICLE 3. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having no par value.

ARTICLE 4. TERM OFF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these articles.

ARTICLE 5. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

ARTICLE 6. BOARD OF DIRECTORS

This Corporation shall have one director(s) initially. The number of directors may be increased or diminished from time to time by the Bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE 7. INITIAL DIRECTOR

The name(s) and street address(es) of the initial director(s) of this Corporation is (are), LAZARO C. LOPEZ, 1943 a Rainbow Dr., Clearwater, FL 34765. The person(s) named as initial director(s) shall hold office for the first year of existence of this Corporation or until their successor(s) is (are) elected or appointed and have qualified, whichever occurs first.

ARTICLE 10. PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE 11. INDEMNIFICATION

The Corporation shall indemnify any officer or director or any former office or director, to the full extent permitted by law.
