**ARTICLE I - NAME**

The name of this corporation is CON PRO INFORMATION SYSTEMS, INC.

**ARTICLE II - CORPORATE EXISTENCE**

The existence of this corporation shall commence on the day of filing; provided that if such day is not authorized under law, then on the earliest day allowable pursuant to Florida law for the commencement of corporate existence. The duration of the corporation shall be perpetual.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of conducting general business.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares, which this corporation shall have authority to issue is Twenty (20) shares of common stock, all of which are to have a par value of One Cent (\$.01).

#### **ARTICLE X - INDEMNIFICATION**

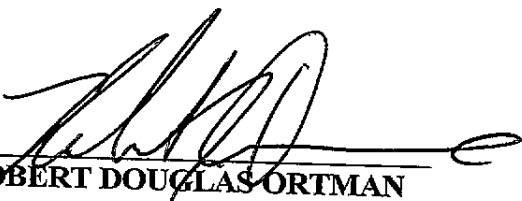
The corporation shall indemnify any officer or director, or any former officer or director of this corporation, to the fullest extent permitted by law.

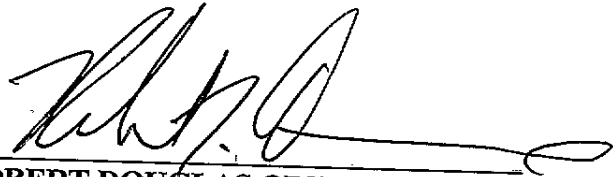
