ARTICLES OF INCORPORATION OF H. L. HUGGINS, INC.

The undersigned incorporators deliver these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act, and hereby at the following Articles of Incorporation.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS
