My client, Lynn Drury P.A., has recently received a 60-day notice that her corporation will be administratively dissolved if the 2003 Uniform Business Report is not filed by September 10, 2003. This Uniform Business Report has been enclosed with this letter, along with the original payment due.

This was my client's first year as a corporation. As such, she was unaware that the Uniform Business Report was due by May 1<sup>st</sup>.
