ARTICLES OF INCORPORATION  
OF  
TOM ALFORD INCORPORATED

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

ARTICLE I – NAME

The name of this corporation is TOM ALFORD INCORPORATED.

ARTICLE II – LOCATION

The principal office of this corporation is to be located at 6001 N.W. 80 Avenue, County of Broward, Tamarac, Florida 33321.

ARTICLE III – NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV – CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is five thousand (5,000) shares of common stock, having a nominal or par value of one dollar (\$1.00) per share.

ARTICLES V – REGISTERED AGENT AND REGISTERED OFFICE

The street address of the initial registered office of this corporation is 6001 N.W. 80 Avenue, Tamarac, Florida 33321, and the name of the initial registered agent of this corporation at that address is Tom Alford.

#### ARTICLE VI – DIRECTORS

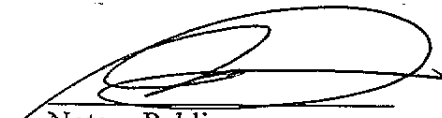
ARTICLE X – AMENDMENT
