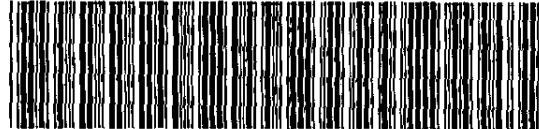

**ARTICLES OF DISSOLUTION
PURSUANT TO SECTIONS 607.1402 and 607.1403
