# ARTICLES OF INCORPORATION (PROFIT)

OZ MAR 25 ALLAU MARY OF AM 9:00 JOSE LUIS GARCIA-GODOS , the undersigned, being of the age of eighteen (18 years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

- 1. The name of the Corporation shall be: QualiCards Inc.
- 2. The number of shares the corporation is authorized to issue shall be 1000 shares all of one class designated as common stock, at \$ 1.00 per value.
- 3. The street address and county of the initial principal office of the corporation is 6533 NW 171st St. Miami Lakes, Fl. 33015 Miami-Dade County and the name of the initial registered agent at this address is Jose Luis Garcia-Godos, residing at 6533 NW 171<sup>31</sup> St., Miami Lakes, Fl. 33015
- 4. The number of directors constituting the initial board of directors shall be one directors and the name and address of the person who is to serve as director until the first meeting of shareholders or until their successors are elected and qualify are:
