The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

3-13-0Z

## Corporate Name and Principal Office

The name of this corporation is Integrated Psychological Systems, Inc., and its principal office and mailing address is 15436 North Florida Avenue, Suite 102, Tampa, Florida 33613.

# **ARTICLE II**

# Commencement of Corporate Existence

The corporation shall come into existence on March 13, 2002.

#### ARTICLE III

### General Nature of Business
