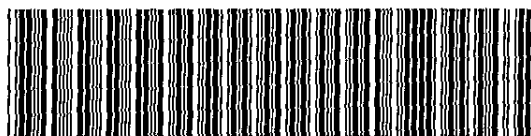

**FIRST AMENDMENT
ARTICLE I - NAME**
