

**ARTICLES OF INCORPORATION  
OF  
The Manas Group, Inc.**

The undersigned, incorporator to these Articles of Incorporation, by these Articles forms a corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is **The Manas Group, Inc.**

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in general investment activities, including but not limited to investments in the gastronomy field, permitted under the laws of the United States and of the State of Florida.

FOURTH. The aggregate number of shares of Capital Stock which the Corporation has authority to issue is ten thousand (10000) all of which shall be one class of common stock having a par value of \$0.01

FIFTH. The address of its initial registered office is 4141 North Miami Avenue, Suite 210-06, Miami, Florida 33127, and the name of the initial Registered Agent at such address is Roberto G. Bravo.

C. The directors of this Corporation shall have the sole discretion to determine the expenses for which the afore-mentioned incorporator shall be reimbursed.

TWELVE. The Corporation reserves the right to amend or repeal any provision contained in the Articles of Incorporation or any amendment to the Articles of Incorporation.



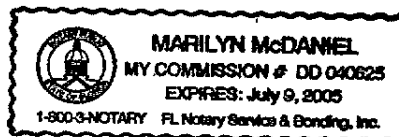
