**ARTICLES OF INCORPORATION  
OF**

**Alvin Jackson, P.A.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation shall be ALVIN JACKSON, P.A.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

To provide legal services and to engage in any lawful act or activity for which the State of Florida permits.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue One Hundred (100 ) shares of Ten Dollar (\$10.00) par value common stock which shall be designated as "Common Shares."

**ARTICLE V - PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 1040 Francis Street, Altamonte Springs, Florida 32701, and the name of the initial registered agent of this corporation at that address is Alvin Jackson, whose address is 1040 Francis Street, Orlando, Florida 32701. Principal address is same as registered.

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

This corporation shall have (1) one director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws, however,


