

ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation, natural people competent to contract, hereby form a professional association under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:


