ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MP-1, INC.

Pursuant to Section 607.1006 of the Business Corporation Act of the State of Florida, the undersigned President of MP-1, INC., a corporation organized and existing under and by virtue of the Business Corporation Act of the State of Florida ("Corporation"), bearing document number P02000032905, does hereby certify:

Article I of the Articles of Incorporation of this Corporation is amended to read in he entirety as follows:

ARTICLE I CORPORATE NAME

The name of Corporation shall be: PHOENIX BIOSCIENCES, INC.

The foregoing amendment was adopted, pursuant to the Florida Business Corporation Act, by a resolution duly adopted by the Board of Directors of the Corporation at a properly called meeting of the Board of Directors on April 6, 2004, and by the holders of a majority of the cutstanding shares of the Common Stock of the Corporation pursuant to written consent dated April 6, 2004.
