**ARTICLE I**

The name and initial address of this corporation shall be A Pro, Inc., 5302 NW 117<sup>th</sup> Avenue, Coral Springs, Florida 33076.

**ARTICLE II**

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV**

The aggregate number of shares which the corporation is authorized to issue is 500 of \$1.00 par value common stock which shall be designated as "Common Shares".
