The undersigned; for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

COMMENCEMENT
AND DURATION

The corporation existence shall commence on *March, 22nd 2002* and shall be perpetual unless terminated by law.

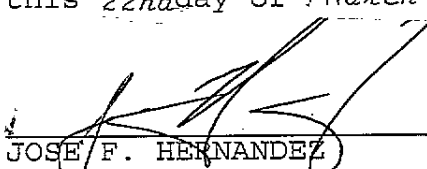
