**ARTICLES OF INCORPORATION
OF
ALIGNED PROPERTIES, INC.**

ARTICLE I - NAME

The name of the corporation is **ALIGNED PROPERTIES, INC.** (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE III - CAPITAL STOCK

The authorized capital stock of this Corporation shall consist of 1,000 shares of common stock, par value One Cent (\$.01). Except as otherwise provided by the Florida Business Corporation Act, each outstanding share of Common Stock is entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

The Corporation shall have two (2) directors initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one.
