Pursuant to the provisions of Chapter 607 and or Chapter 621, Florida Statutes, the undersigned hereby adopt the following Articles of Incorporation.

**ARTICLE I**  
**Name**

The name of the corporation is **TMG Insurance Services, Inc.** (The "Corporation").

**ARTICLE II**  
**Duration**

The Corporation shall have perpetual duration from the date of corporation, unless it is sooner dissolved and its affairs wound up in accordance with the Act.

**ARTICLE III**  
**Purpose**

The purpose for which the corporation is formed is for selling insurance.

**ARTICLE IV**  
**Registered Office; Registered Agent & PRINCIPAL ADDRESS**
