ARTICLES OF INCORPORATION

<u>OF</u>

SUNSHINE COMMUNICATIONS, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is **SUNSHINE COMMUNICATIONS**, **INC**. hereinafter referred to as the "Corporation".
