The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be Manasota Texture Services, Inc., Inc. and the principal place of business of this corporation shall be 313 Lantana Avenue, Sarasota, FL 34243 and the mailing address of the corporation shall be 313 Lantana Avenue, Sarasota, FL 34243.






