ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: HEAVY DUTIES, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 11902 Woodside Drive, Riverview, Florida 33569.

The principal mailing address of this corporation shall be: PO Box 1268, Ruskin, Florida 33570.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of heavy grading; and
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is Five Hundred (500). Such shares shall be of one class, and shall have a par value of One Dollar (\$1.00) per share.
