# ARTICLES OF INCORPORATION OF

The undersigned, in order to form a corporation for the purpose herejnatter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as following:

#### ARTICLE I

#### <u>NAME</u>

The name of this corporation is: <u>LAZULI CORP.</u>

#### ARTICLE II

#### PURPOSE

The general nature of the business to be transacted by this corporation shall be:

machinery and plants, and any and all structures and crections which may at any time necessary, useful, or advantageous in the judgment of the Board of Directors, for the purpose of the Corporation, and which can lawfully be done.

- E) To borrow money with or without pledge of or mortgage on all or any of its property, real or personal, as security and to loan and advance money upon mortgages on personal or real property or on either of them.

carry on, pursuant to the provisions of these Articles of Incorporation.

I) To all such acts and things as are incident or conducive to the premises.

J) This Corporation shall have the power conduct its business in all its branches in the State of Florida, or in any other State or States or territories of the United States, or in the District of Columbia, and the dependencies of the United States of in foreign countries, and ultimately to do all acts and things and to exercise all the powers now or hereafter authorized by law necessary to carry on the business of said corporation, or to promote any of the subjects or objects for which the corporation if formed.


