Dear Division of Corporations:

Yesterday my accountant informed me that she had checked the *sunbiz.org* web site and that my Corporation (Soltec International Inc.) is listed as inactive. She asked me if I had filed the Uniform Business Report for the State of Florida earlier this year. She also explained the type of form that I should have received in the mail and that this form should have arrived in early 2003.

I did not receive this form, however I was out of state for two months taking care of my mother who was in a serious accident. While I was out of state, I had all my mail forwarded to Alabama. The process of forwarding the mail caused me many problems and I think the UBR form was likely lost in the mail or never forwarded to me in Alabama. In any case, I did not receive the form. Since I am a new business owner and this is the first year I would need to file this form, I was not even aware that I should have received the form until my accountant asked me about it.

This morning I called the Division of Corporations to ask how I should proceed. I was informed that I should complete a blank UBR form, attach a check for \$150 and include a letter of explanation. I have included the completed form and check with this letter. I respectfully ask that you waive the penalty fee this year. Thank you for your consideration.
